

Notice is hereby given, pursuant to Section 16-50l(b) of the Connecticut General Statutes and Regulations pertaining thereto, of an Application to be submitted to the Connecticut Siting Council ("Council") on or about August 17, 2012, by Cellco Partnership d/b/a Verizon Wireless ("Cellco" or the "Applicant"). The Application proposes the installation of a wireless telecommunications facility on an 8.85 acre parcel at 77 Milford Street in Burlington, Connecticut. Cellco proposes to construct a 110-foot monopole tower in the southerly portion of this parcel. Access to the facility compound will extend from Milford Street. Cellco will also install a new 12' x 30' shelter located near the base of the tower to house its radio equipment and a back-up generator. The location and other features of the proposed facility are subject to change under provisions of Connecticut General Statutes § 16-50g et. seq.

On the day of the Siting Council public hearing on this proposal, Cellco will fly a balloon at the height of the proposed tower described above.
