List 8: Low-fat and Reduced Fat 100% Natural Cheese

List 8: Cheese (low-fat and reduced fat 100 percent natural cheese) includes commercial products that meet the CNS snacks category, such as cheese and cheese sticks.

The Food and Drug Administration (FDA) defines natural cheese as cheese made directly from milk, e.g., cheddar, Colby, Monterey Jack, mozzarella, muenster, provolone, Swiss, feta, brie and pasteurized blended cheese made by blending two or more different natural cheeses. Natural cheeses do not include pasteurized process cheese (e.g., American), pasteurized process cheese food, pasteurized process cheese spread or pasteurized process cheese products.

Exempt from fat and saturated fat standards: Low-fat and reduced fat 100 percent natural cheese
